## How does the program work?

Review the enclosed Sales Agreement, complete it, and fax, scan, or mail it to our office. Or just call us at 860-3843691. You can also submit your sales agreement electronically on our website. There's no waiting to receive your brochures! You'll receive your brochures within $4-5$ days. Brochures will be shipped FREE! We will create your organization's custom online store.

We can also customize a participant letter to include your goals, dates, payment options, and tips for increasing sales.

Distribute brochures and participant letters to your sellers. Collect orders and payments with your brochures, and sell for 2-3 weeks. We encourage closing on a Monday rather than a Friday to allow your participants to sell over the weekend. Customer checks, if accepted, are made payable to your organization.

Collect all brochures and payments at the end of your selling period. The minimum order is 50 items.
We will email an invoice for the amount due, and you'll keep your profit upfront.
Shipping is a flat $\$ 75$ fee.
Pay for your purchase. Payment by school/organization check, money order, cashier, or certified check is required.
Purchase Orders and payments by credit card are not accepted. W-9s and vendor applications are supplied as needed.

Confirmation will be emailed to you once we receive payment. Once payment has been received, your order will be submitted to our shipping department for processing. Products are delivered via FedEx/UPS or Common Carrier generally within 1 week.

Report any missing or broken items. Seldom are there any missing or broken items with our shipments. However, should any corrections be required, return the check-in form within 48 hours and we will process a new order for the replacements.

We'll provide coaching to help your campaign succeed, extended office hours Mon-Fri 9 am-9 pm, Sat-Sun 11 am- 6 pm EST, and a solid commitment to process your order and needed replacements with no delay. When you require assistance, we'll be available to help you!

Samples/Late Orders: Regular pricing applies plus shipping.
Tax Exemption: Organizations who are tax-exempt are responsible for determining their state tax exemption status. Organizations that are not exempt will be responsible for reporting state tax to their appropriate state. Non-exempt organizations may collect the tax.
Shipping: A flat $\$ 75$ shipping fee is added to your invoice. Orders will usually ship within 2-3 weeks upon receipt of payment and are generally shipped via FedEx. Large orders are shipped by a freight carrier with an arranged delivery.
Brochures: We ship brochures at no upfront cost to your organization, but we do request enough items are sold to cover costs. A fee is added to an invoice only if the total number of items sold is less than the total number of brochures shipped. A 20 cents fee is calculated only on the shortage. For example, order 100 brochures, only 7 participate and sell 10 items each for a total of 70 items sold, a small fee is added for just 30 brochures. $(30 \times .20=\$ 6.00)$

Payments: Customer checks are made payable to your organization. Acceptable forms of payment include Money Order, Business, or School Check. Personal checks, temporary checks, checks with hand-written group/business names, electronic credit cards, and purchase orders are not accepted. Payments by check/money order must be paid in full before the order being placed. Returned check fee is $\$ 50.00$. Public school purchase orders are accepted.

Missing Items: Report any missing items within 48 hours following delivery. Send an email with the name of the item, how many were received, and the quantity missing. The organization will be responsible for the accuracy of the total number of items sold and ordered.

Sales Agreement: MUST be returned to Deb Anderson before distributing your brochures. I have read, understand, and agree with the terms and conditions listed above and have received approval from my organization (school principal, board members, etc.) to sign on behalf of my organization.
